Terms and Conditions

- 1) Weekday Grabs LENDLEASE PLUS MEMBERS EXCLUSIVE 10 May – 23 June 2024 (both dates inclusive)
 - a) Lendlease Plus Members are eligible to receive 10,000 Plus\$ with a minimum nett spend of S\$150 on weekdays at 313@somerset, within a maximum of three (3) combined same-day receipts.
