

313@somerset – LINE Trivia Quiz Giveaway

Terms & Conditions

1. The contest described in this document (“Contest”) is organised and promoted by Lendlease Retail Investments 1 Pte Ltd, 313 Orchard Road, 313@somerset, #05-04, Singapore 238895 (“Landlord”) through its managing agent Lendlease Retail Pte Ltd (“Lendlease Retail”).
2. By participating in the Contest, participants agree to be bound by the terms and conditions of the Contest (“Terms”) which at the date of publication are set out below. Lendlease Retail reserves the right to change the Terms (including the dates of the Contest and the prizes or their value) at its sole discretion without notice.
3. Except as other specified in these Terms, Lendlease Retail’s decision on all matters relating to the Contest is final, conclusive and binding on all participants and no correspondence will be entertained.

The Contest

4. Lendlease Retail has organized an online contest (“LINE Trivia Quiz Giveaway”) whereby LINE users who answer the trivia quiz correctly in the LINE mobile application will stand to win S\$10 in Lendlease voucher. The trivia quiz will be from 26 November to 14 December 2018, on Mondays, Wednesdays and Fridays, with a total of S\$7,000 worth of Lendlease vouchers to be given out.

To qualify for this Contest, participants will have to install LINE mobile application on their compatible smartphone and follow 313@somerset LINE Official Account on LINE. Once participants have successfully followed the account, participants will receive notification on the quiz and the participation instruction. Each participant can send an entry not more than once from 11:00:00 onwards for each quiz. All entries must be received by LINE’s system by 09:59:59 Singapore time on the next day.

5. Each participant is only eligible to win one (1) time throughout the contest duration. Winners will be notified immediately via LINE mobile application as at time of participation. Each winner is only entitled to one (1) S\$10 in Lendlease voucher. Prizes are not transferrable and not redeemable for cash, credit or otherwise. Lendlease vouchers are only valid for use at participating shops and F&B outlets at Lendlease-managed malls.
6. Prizes can be collected at the Concierge Desk on Basement 1 at 313@somerset from Monday to Sunday, 1000hrs to 2130hrs. Prize winners are required to collect their prize personally. Upon collection, prize winners have to provide their full name, date of birth, mobile number and email address and show the winning notification on their LINE mobile application, on a compatible smartphone or tablet to the Concierge personnel representative. The Concierge representative will be required to press on the “Invalidate Coupon” button on each winning notification per winner after each successful prize collection, after which the winning notification will be made void thereafter.

If the prize collection is valid and successful, the Concierge personal representative may request a prize collection validation endorsement in the form of a signature to confirm that a prize has been collected and redeemed. Winners are required to show adequate identification. No other repeated prize collection or redemption by the same participant will be entertained. Prizes not collected by 30 December 2018 will be forfeited.
