# 313@somerset Tourist Exclusive Promotions

### **Terms and Conditions**

#### 1) Spend And Redeem

1 March 2024 to 31 March 2025 (both dates inclusive)

- a) Tourists are eligible to receive one (1) exclusive 313 gift with a minimum nett spend of S\$150 at 313@somerset, within a maximum of three (3) combined same-day receipts.
- b) Tourists will be automatically enrolled in 313 Tourist Programme upon redemption of the gift.
