

## Fashionably Green @313 (10 March – 23 April 2023)

### Terms and Conditions

#### 1) Shop & Be Rewarded

10 March 2023 – 23 April 2023 (both dates inclusive)

All items are required to be in clean and good condition and will be screened to ensure consistent quality. There is no maximum cap to the total quantity of clothing apparel that each participant can drop-off during the drop-off period from 21 – 28 March 2023. On Fashion Swap Day, each participant can swap up to a maximum of 5 fashion apparel.
